

ORDINANCE 2020-03

AN ORDINANCE REPEALING AND RECREATING SECTIONS 11.01(BOARD OF HEALTH POWERS AND DUITES), 11.02(HEALTH OFFICER), 11.04(HEALTH NUISANCES, ABATEMENT), AND 11.05(COMMUNICABLE DISEASES) OF THE MUNICIPAL CODE OF THE CITY OF PRAIRIE DU CHIEN, CRAWFORD COUNTY, WISCONSIN.

The Common Council of the City of Prairie du Chien, Crawford County, Wisconsin, does hereby ordain as follows:

Section 1: That Section 11.01, 11.02, 11.04, and 11.05 of the Municipal Code of the City of Prairie du Chien, Wisconsin be repealed and re-created to read as follows:

11.01 (BOARD OF HEALTH; POWERS AND DUTIES)

The Board of Health of the City shall assume the general administration of health and sanitation laws and regulations in the City, supervise the work of the Health Officer and attend to the administration and enforcement of the health laws of the state and the rules and regulations prescribed by the State Department of Health Services and the ordinances of the City.

11.02 (HEALTH OFFICER)

(1) **POWERS AND DUTIES.** The Health Officer, under the supervision of the District State Health Officer shall:

- (a) Maintain continuous sanitary supervision over his or her territory.
- (b) Promote the spread of information as to the causes, nature, and prevention of prevalent diseases and the preservation and improvement of health.
- (c) Perform all duties required by and enforce all health laws, rules, and regulations of the State of Wisconsin, the State Department of Health Services, and the City, including laws relating to contagious diseases contained in Ch. 252, Wis. Stats.
- (d) Keep and deliver to his or her successor a record of all his or her official acts.
- (e) Make reports to the State Department of Health Services and to the Council as they may request.

(2) **MATERIALS AND SUPPLIES.** The Health Officer may procure, at the expense of the City, all record books, quarantine cards and other material needed by the Board of Health, except such as are furnished by the State Department of Health Services.

11.04 (HEALTH NUISANCES, ABATEMENT)

The Health Officer or the Board of Health may abate health nuisances in accordance with 254.59, Wis. Stats., which is adopted by reference and made a part of this chapter as if fully set forth herein.

11.05 (COMMUNICABLE DISEASES)

(1) **ADOPTION OF STATE LAW.** Chapter 252, Wis. Stats., and Wis. Adm. Code DHS 145 are adopted by reference and made a part of this chapter and the Health Officer shall enforce the provisions thereof. The City specifically adopts the enforcement provisions and penalties set forth in 252.25, Wis. Stats for violations or obstructions of this subsection.

(2) **QUARANTINE RESTRICTIONS.** No person, whether afflicted with a communicable disease as defined in Wis. Stats. Chpt. 252 and quarantined under Wis. Stats. sec. 252.06 or not, shall visit or depart from any premises that has been quarantined by the Health Officer until given permission to visit or depart by said Health Officer. Any person who violates the provisions of this subsection shall be subject to a fine of not less than \$100.00 nor more than \$500.00

Section 2: Any ordinance or parts thereof inconsistent herewith are hereby repealed.

Section 3: This Ordinance shall be effective from its passage and publication as required by law.
